DRIVER'S CERTIFICATION

AT THE END OF THE REPORT, THE DRIVER CERTIFIES THAT THE INSPECTION WAS CONDUCTED THOROUGHLY AND HONESTLY. THIS CERTIFICATION HOLDS THE DRIVER ACCOUNTABLE FOR THE ACCURACY OF THE INFORMATION PROVIDED AND ENSURES COMPLIANCE

WITH REGULATORY STANDARDS.

LEGAL AND REGULATORY REQUIREMENTS
