## 2. MOBILE APP ACCESS

WESTERN UNION ALSO OFFERS A MOBILE APP FOR BOTH IOS AND ANDROID DEVICES. TO ACCESS YOUR TRANSACTION HISTORY THROUGH THE APP:

- STEP 1: DOWNLOAD AND INSTALL THE WESTERN UNION APP FROM YOUR DEVICE'S APP STORE.
- STEP 2: LOG IN TO YOUR ACCOUNT.
- STEP 3: TAP ON "TRANSACTION HISTORY" TO VIEW YOUR PAST TRANSACTIONS.
- STEP 4: YOU CAN CHOOSE TO EXPORT OR SHARE YOUR TRANSACTION DETAILS DIRECTLY FROM THE APP.

## 3. CUSTOMER SERVICE SUPPORT

IF YOU ENCOUNTER ANY ISSUES ACCESSING YOUR TRANSACTION HISTORY ONLINE OR THROUGH THE APP, YOU CAN ALWAYS REACH OUT TO WESTERN UNION'S CUSTOMER SERVICE:

- PHONE SUPPORT: CALL THE CUSTOMER SERVICE NUMBER AVAILABLE ON THE WESTERN UNION WEBSITE.
- EMAIL SUPPORT: SEND AN EMAIL DETAILING YOUR REQUEST FOR TRANSACTION HISTORY.
- IN-PERSON REQUEST: VISIT A LOCAL WESTERN UNION AGENT LOCATION AND ASK FOR ASSISTANCE IN OBTAINING YOUR TRANSACTION HISTORY.

## IMPORTANT CONSIDERATIONS

WHILE REQUESTING YOUR TRANSACTION HISTORY, THERE ARE SEVERAL IMPORTANT FACTORS TO KEEP IN MIND:

### 1. PRIVACY AND SECURITY

IN MOST CASES, ACCESSING YOUR TRANSACTION HISTORY THROUGH ONLINE OR APP PLATFORMS IS FREE. HOWEVER, IF YOU REQUEST A PRINTED COPY OR DETAILED REPORT THROUGH CUSTOMER SERVICE, THERE MAY BE A FEE INVOLVED.

### 4. REGULAR MONITORING

TO KEEP YOUR FINANCES IN CHECK, IT'S ADVISABLE TO REGULARLY MONITOR YOUR TRANSACTION HISTORY. THIS PRACTICE CAN HELP YOU STAY INFORMED ABOUT YOUR FINANCIAL ACTIVITIES AND DETECT ANY UNAUTHORIZED TRANSACTIONS PROMPTLY.

## KEEPING YOUR TRANSACTIONS ORGANIZED

ONCE YOU HAVE ACCESSED YOUR TRANSACTION HISTORY, IT'S IMPORTANT TO ORGANIZE AND MAINTAIN THESE RECORDS EFFECTIVELY. HERE ARE SOME TIPS:

## **WHAT SHOULD I DO IF I NOTICE AN ERROR IN MY WESTERN UNION TRANSACTION HISTORY?**

IF YOU NOTICE AN ERROR IN YOUR TRANSACTION HISTORY, CONTACT WESTERN UNION CUSTOMER SERVICE IMMEDIATELY TO REPORT THE ISSUE AND SEEK CLARIFICATION OR CORRECTION.

## **IS MY WESTERN UNION TRANSACTION HISTORY SECURE?**

YES, YOUR WESTERN UNION TRANSACTION HISTORY IS SECURE. WESTERN UNION EMPLOYS ENCRYPTION AND OTHER SECURITY MEASURES TO PROTECT YOUR PERSONAL AND FINANCIAL INFORMATION.
