- GRANTS: THESE ARE FUNDS THAT DO NOT NEED TO BE REPAYED AND ARE AWARDED BASED ON FINANCIAL NEED. WESLEYAN OFFERS SUBSTANTIAL GRANT AID, WHICH OFTEN COVERS A SIGNIFICANT PORTION OF TUITION AND FEES.

2. MERIT-BASED SCHOLARSHIPS

MERIT-BASED SCHOLARSHIPS AT WESLEYAN ARE AWARDED TO STUDENTS WHO DEMONSTRATE EXCEPTIONAL ACADEMIC PERFORMANCE OR NOTABLE ACHIEVEMENTS IN EXTRACURRICULAR ACTIVITIES. THESE SCHOLARSHIPS ARE TYPICALLY AWARDED AT THE TIME OF ADMISSION AND CAN SIGNIFICANTLY REDUCE A STUDENT'S OVERALL COST OF ATTENDANCE.

3. EXTERNAL SCHOLARSHIPS

STUDENTS ARE ENCOURAGED TO SEEK EXTERNAL SCHOLARSHIPS FROM PRIVATE ORGANIZATIONS, BUSINESSES, AND FOUNDATIONS. WESLEYAN ALLOWS STUDENTS TO USE THESE SCHOLARSHIPS TO COMPLEMENT THEIR FINANCIAL AID PACKAGES. HOWEVER, IT IS ESSENTIAL TO INFORM THE FINANCIAL AID OFFICE OF ANY EXTERNAL AWARDS RECEIVED TO ENSURE PROPER ADJUSTMENTS TO THE FINANCIAL AID OFFER.

APPLYING FOR FINANCIAL AID

THE PROCESS OF APPLYING FOR FINANCIAL AID AT WESLEYAN UNIVERSITY INVOLVES SEVERAL STEPS. STUDENTS SHOULD BE WELL-PREPARED TO NAVIGATE THIS PROCESS TO MAXIMIZE THEIR FINANCIAL AID OPPORTUNITIES.

1. COMPLETE THE FAFSA

THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) IS THE FIRST STEP IN DETERMINING ELIGIBILITY FOR NEED-BASED FINANCIAL AID AT WESLEYAN. THE FAFSA COLLECTS FINANCIAL INFORMATION FROM STUDENTS AND THEIR FAMILIES TO ASSESS THEIR FINANCIAL NEED. HERE ARE THE KEY POINTS TO CONSIDER:

- FILING DATE: STUDENTS SHOULD COMPLETE THE FAFSA AS SOON AS POSSIBLE AFTER OCTOBER 1 OF THEIR SENIOR YEAR IN HIGH SCHOOL. WESLEYAN'S PRIORITY DEADLINE IS TYPICALLY FEBRUARY 15.

- FILING DATE: THE CSS PROFILE SHOULD ALSO BE SUBMITTED BY FEBRUARY 15.
- DOCUMENTATION: FAMILIES MAY NEED TO PROVIDE ADDITIONAL DOCUMENTS SUCH AS TAX RETURNS, W-2 FORMS, AND OTHER FINANCIAL STATEMENTS.

3. REVIEW FINANCIAL AID OFFERS

ONCE THE FAFSA AND CSS PROFILE ARE PROCESSED, STUDENTS WILL RECEIVE THEIR FINANCIAL AID OFFERS. IT IS ESSENTIAL TO REVIEW THE OFFER CAREFULLY, AS IT OUTLINES THE TYPES AND AMOUNTS OF AID AVAILABLE. STUDENTS SHOULD CONSIDER THE FOLLOWING:

- UNDERSTANDING THE COMPONENTS: TAKE TIME TO UNDERSTAND THE BREAKDOWN OF GRANTS, SCHOLARSHIPS, LOANS, AND WORK-STUDY OPPORTUNITIES INCLUDED IN THE OFFER.
- COMPARING OFFERS: IF STUDENTS HAVE APPLIED TO MULTIPLE INSTITUTIONS, COMPARING FINANCIAL AID OFFERS CAN HELP IN MAKING AN INFORMED DECISION ABOUT WHERE TO ATTEND.

MANAGING FINANCIAL AID

ONCE STUDENTS ARE ENROLLED AT WESLEYAN UNIVERSITY, MANAGING FINANCIAL AID BECOMES A VITAL PART OF THEIR ACADEMIC JOURNEY. HERE ARE SOME STRATEGIES FOR EFFECTIVELY MANAGING FINANCIAL AID:

1. STAY INFORMED ABOUT FINANCIAL AID POLICIES
