ELIGIBILITY REQUIREMENTS FOR WASHINGTON OCCUPATIONAL THERAPY LICENSE

TO OBTAIN A WASHINGTON OCCUPATIONAL THERAPY LICENSE, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY THE WASHINGTON STATE DEPARTMENT OF HEALTH. EDUCATIONAL BACKGROUND

WHILE DIRECT PROFESSIONAL EXPERIENCE IS NOT ALWAYS MANDATORY BEFORE APPLYING FOR THE INITIAL LICENSE, COMPLETION OF SUPERVISED FIELDWORK OR CLINICAL INTERNSHIPS AS PART OF THE EDUCATIONAL PROGRAM IS REQUIRED. THIS SUPERVISED PRACTICE ENSURES PRACTICAL SKILLS AND READINESS FOR PROFESSIONAL RESPONSIBILITIES.

CRIMINAL BACKGROUND CHECK

WASHINGTON'S LICENSING BOARD MANDATES A CRIMINAL BACKGROUND CHECK FOR ALL APPLICANTS. THIS PROCESS HELPS PROTECT THE PUBLIC BY VERIFYING THAT APPLICANTS DO NOT HAVE DISQUALIFYING CRIMINAL HISTORY THAT WOULD IMPAIR THEIR ABILITY TO PRACTICE SAFELY AND ETHICALLY.

APPLICATION PROCESS AND DOCUMENTATION

NATIONAL BOARD FOR CERTIFICATION IN OCCUPATIONAL THERAPY (NBCOT) EXAM

THE NBCOT CERTIFICATION EXAM IS THE PRIMARY EXAMINATION REQUIRED BY WASHINGTON STATE. SUCCESSFUL COMPLETION OF THIS EXAM DEMONSTRATES THAT THE CANDIDATE HAS MET NATIONAL STANDARDS FOR OCCUPATIONAL THERAPY KNOWLEDGE AND PRACTICE.

STATE JURISPRUDENCE EXAMINATION

IN ADDITION TO THE NBCOT EXAM, WASHINGTON MAY REQUIRE APPLICANTS TO PASS A JURISPRUDENCE EXAM FOCUSED ON STATE LAWS, RULES, AND ETHICAL STANDARDS GOVERNING OCCUPATIONAL THERAPY PRACTICE WITHIN WASHINGTON. THIS ENSURES THAT LICENSEES UNDERSTAND THEIR LEGAL RESPONSIBILITIES.

LICENSE RENEWAL AND CONTINUING EDUCATION

SCOPE OF PRACTICE AND REGULATORY COMPLIANCE

SUPERVISION AND COLLABORATION

PREPARING FOR EXAMINATIONS

THOROUGH PREPARATION FOR BOTH THE NBCOT AND STATE JURISPRUDENCE EXAMS INCREASES THE LIKELIHOOD OF SUCCESS. UTILIZING OFFICIAL STUDY GUIDES AND PRACTICE TESTS CAN IMPROVE OUTCOMES.

STAYING INFORMED

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE REQUIREMENTS TO OBTAIN AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON STATE?

TO OBTAIN AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON, APPLICANTS MUST HAVE A DEGREE FROM AN ACCREDITED OCCUPATIONAL THERAPY PROGRAM, PASS THE NBCOT CERTIFICATION EXAM, COMPLETE A CRIMINAL BACKGROUND CHECK, AND SUBMIT AN APPLICATION WITH THE REQUIRED FEES TO THE WASHINGTON DEPARTMENT OF HEALTH.

HOW LONG DOES IT TAKE TO GET AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON?

THE PROCESSING TIME FOR AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON TYPICALLY RANGES FROM 4 TO 8 WEEKS AFTER SUBMITTING A COMPLETE APPLICATION AND PASSING ALL REQUIREMENTS, INCLUDING BACKGROUND CHECKS AND EXAM RESULTS.

IS CONTINUING EDUCATION REQUIRED TO MAINTAIN AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON?

YES, LICENSED OCCUPATIONAL THERAPISTS IN WASHINGTON ARE REQUIRED TO COMPLETE AT LEAST 24 HOURS OF CONTINUING EDUCATION EVERY TWO YEARS TO RENEW THEIR LICENSE AND STAY COMPLIANT WITH THE STATE'S REGULATIONS.

CAN AN OCCUPATIONAL THERAPIST LICENSED IN ANOTHER STATE PRACTICE IN WASHINGTON WITHOUT OBTAINING A NEW LICENSE?

NO, OCCUPATIONAL THERAPISTS LICENSED IN ANOTHER STATE MUST APPLY FOR AND OBTAIN A WASHINGTON STATE OCCUPATIONAL THERAPY LICENSE THROUGH ENDORSEMENT BEFORE THEY CAN PRACTICE LEGALLY IN WASHINGTON.

WHERE CAN I APPLY FOR AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON?

APPLICATIONS FOR AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON CAN BE SUBMITTED ONLINE THROUGH THE WASHINGTON DEPARTMENT OF HEALTH'S PROFESSIONAL LICENSING PORTAL OR BY MAILING A COMPLETED PAPER APPLICATION TO THE DEPARTMENT.

WHAT IS THE RENEWAL PROCESS FOR AN OCCUPATIONAL THERAPY LICENSE IN WASHINGTON?

OCCUPATIONAL THERAPY LICENSES IN WASHINGTON MUST BE RENEWED EVERY TWO YEARS. RENEWAL REQUIRES SUBMITTING A RENEWAL APPLICATION, PAYING THE RENEWAL FEE, AND PROVIDING PROOF OF COMPLETION OF THE REQUIRED CONTINUING EDUCATION HOURS.
